## School Facility Conditions and Planned Improvements

Rocklin Alternative Education Center is located at 3250 Victory Drive. This beautiful facility opened in January 2000. Students and staff take pride in the appearance of our school, and our lead custodian works to ensure that our campus is always clean and safe. The district maintenance and grounds crew also pay regular visits and make inspections at our campus. All visitors to the campus are required to sign-in in the administrative office.

The district takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the district uses a facility survey instrument developed by the State of California Office of Public School Construction. District maintenance ensures that the repairs necessary to keep the school sites in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

## Percentage of Students Meeting or Exceeding the State Standard on CAASPP

## 2021-22 School Safety Plan

All schools in the Rocklin Unified School District have a Comprehensive School Safety Plan approved by the School Site Council. It includes an assessment of the current status of school crime, procedures to notify teachers of dangerous pupils, disaster procedures, child abuse reporting procedures, rules and procedures on school discipline, school wide dress code, policies regarding actions which would lead to suspension/expulsion, sexual harassment policy, procedures for the safe ingress and egress of pupils, and other safe school strategies and programs. It also includes an action plan for implementation.

Our Safety Plan is updated each February of the school year based on feedback from District personnel, staff discussions and the School Resource Officer as well as lessons from prior experiences. The Safety Plan, specifically the procedures on school discipline, disaster protocol, and harassment are reviewed with the staff each August prior to the start of the school year (with three emergency drills scheduled before the end of October and a variety of drills scheduled every other month throughout the year). Documentation is collected following each drill and reviewed by the Emergency Response Team. If necessary, enhancements to those procedures are made based on feedback. Last year's Comprehensive School Safety Plan was approved by Site Council February 24, 2021.
